Financial Assistance Policies

- Financial aid awards are determined on a sliding scale based on household size and household income.
- You must indicate with kind of award(s) you wish to receive (membership, camp, programs, and/or childcare)
- Applicants that appeal their award decision will have their application reviewed by the Vice President of Operations.
- Awards are confined to the dates on the financial aid award letter. The applicant is responsible to reapply with current income verification prior to the end date of their award or as requested by the West Suburban YMCA. The West Suburban YMCA will send a financial aid expiration notice at least 30 days prior to expiration.
- All financial assistance and income information is kept confidential.

Income Verification

In addition to this form, applicants must provide income information for their entire household to be considered for a financial aid award regardless. Acceptable income verification documents include:
